Terms and Conditions of MOSAIC and the Brighton Marathon

Terms and Conditions of MOSAIC:

1. I agree to take part in the 2011 Brighton Marathon scheduled to take place on **Sunday 10th April 2011** (“the Event”) on behalf of MOSAIC Black and Mixed-Parentage Family Group (“MOSAIC”).
2. I acknowledge that to participate in the Event on a MOSAIC place, I must pay a non-refundable registration fee of **£48** (forty-eight pounds inc. VAT) and pledge to raise a minimum of **£200** (two hundred pounds) in sponsorship (excluding gift aid) by **16 May 2011**. I understand that I am expected to make up the shortfall myself by **31 May 2011** if applicable. I understand that if I decide not to run the marathon and cannot find someone to replace me by **4 February 2011**, I will be responsible for the remainder of MOSAIC’s cost of my charity place in the amount of **£69.50** (sixty-nine pounds, fifty pence) at the Trustees’ discretion. *I understand that if I have already secured my own place in the event I am not required to pay a registration fee or make a minimum sponsorship pledge, but I am encouraged to raise as much as I can.*
3. Any and all monies raised in connection with the 2011 Brighton Marathon must be passed to MOSAIC no later than **16 May 2011**. I hereby accept full responsibility for ensuring that all sponsorship monies/donations received by me for the 2011 Brighton Marathon will be paid to MOSAIC without delay.
4. I hereby enclose a registration fee of **£48** (forty-eight pounds inc. VAT) and understand that this is a non-refundable registration deposit, and will not be deducted from or included in my sponsorship target.
5. I will inform MOSAIC as soon as possible in the event I suffer any injury or become aware of any other material reason which would prohibit me from taking part in the Event.
6. I warrant that I will be at least **18 years of age** as of the **10th April 2011** and understand the risks in taking part in this Event. Additionally, I know of no illness, injury or medical condition from which I suffer and which would prohibit or affect my participation in the Event and, in any case, confirm that I will seek medical advice before participating in the Event to ensure that I am in a fit physical state to participate.
7. I shall not hold MOSAIC liable for death, personal injury/damage or illness that I may suffer while participating in the Event save for where death or personal injury is caused by the negligence of MOSAIC.
8. I am happy to allow MOSAIC to use my name and any footage, audio or photograph(s) taken of me during the 2011 Brighton Marathon without further notification as part of its publications, promotion and advertising activities.



Terms and Conditions of the Brighton Marathon :

1. I understand that participating in this event is potentially hazardous, and that I should not enter and participate unless I am medically able and properly trained.
2. In consideration of the acceptance of this entry, I assume full and complete responsibility for any injury or accident which may occur while I am traveling to or from the event, during the event, or while I am on the premises of the event.
3. I also am aware of and assume all risks associated with participating in this event, including but not limited to falls, contact with other participants, effect of weather, traffic, and conditions of the road. I, for myself and my heirs and executors, hereby waive, release and forever discharge the event organizers, sponsors, promoters, Active.com and each of their agents, representatives, successors and assigns, and all other persons associated with the event, for all my liabilities, claims, actions, or damages that I may have against them arising out of or in any way connected with my participation in this event.
